- Discussed with Canberra Venues the issues surrounding Stromlo Forest Park, the review of EPIC and the National Arboretum
- Raised parking issues across the city and around sporting venues with Access Canberra, Transport Canberra and Planning Minister Mick Gentleman and his advisors, also proposing the concept of a 3-day visitor car park pass
- Briefed Minister Meegan Fitzharris on the National Convention Centre and parking issues in Civic and beyond,
- Met with ACT MLA's Caroline Le Couteur, Bec Cody and Tara Cheyne on tourism related matters
- Preparation of a policy paper for submission to the ACT Government's 2019-2020 budget deliberations
- Met several times with the City Renewal Authority on their Precinct Renewal Programs
- Meetings with Brand Canberra Board members and others on the potential tie in of the brand with tourism and allied sectors

#### **Federal Government and National Issues**

- Met with Ben Morton, Chair of the Inquiry into Canberra's National Institutions and Member for Canberra Gai Brodtmann Deputy Chair
- Meetings with the National Capital Authority on a number of matters surrounding the Parliamentary Precinct and their involvement and contribution to tourism and the visitor economy
- Brief by the NCA CEO on the USA study tour examining the Smithsonian institution's collaboration and Ottawa's Parliamentary Precinct

- Met individually with sports administrators from the Brumbies, Raiders, Tennis ACT, Cricket ACT, Hockey ACT and Capital Football on a range of issues facing their respective sports, including parking, traffic flow and sports grounds issues. Also discussed sports development with UC's new Director of Sport
- Discussed the current Visit Canberra Events Funding program and the criteria for applying for grants that is in need of review. Also discussed major events funding criteria.
- Viewed plans on the proposed Majura Valley tourism precinct
- Discussed plans for a major tourism development proposal for Kingston
- Presentation by Visit Canberra on the outcomes of the international traveller satisfaction survey conducted at the International Airport by the University of Canberra
- Discussed the state of the Canberra Region Wine Industry and their marketing plans with new Secretary of the CDWIA
- Discussions with operators on the school market, accommodation challenges, seasonal visitation issues and visitation limitations to national attractions
- Meetings and discussions with property developers and investors on current ACT planning legislation
- Meetings with Singapore Airlines and Qantas on aviation matters
- Meetings surrounding the plans for a New National Convention Centre with proponents of a new private sector-built facility
- Examined and discussed plans with Screen Canberra on their potential expansion and future of their film pre-production studios in Canberra and support of interactive entertainment start-ups

- Recommended funding for the ACT Design Festival be continued and fostered as an event with substantial growth potential
