These speakers, all leaders and experts in the respective areas of responsibility, gave their time freely to address our Forums on a variety of pertinent topics.

These meetings attracted up to 150 industry leaders each month, and the Canberra Region Tourism Advisory Forum was the only regular gathering of its type in Australia to each month bring together the sectors driving the visitor economy during this Covid-19 Pandemic

I would like to thank the National Convention Centre General Manager Stephen Wood and his team, including Encore, for hosting these Forums during what was a very difficult year for the Centre. I would also sincerely thank Visit Canberra and Jonathan Kobus for sponsoring these Forums.



Other Activities

Covid and Liaison with the ACT Government

- Members of the Tourism Leaders Forum met with Chief Minister Andrew Barr and also frequently with the Chief Minister's Tourism Advisors over a number of issues
- The Tourism Leaders Forum engaged frequently with the Deputy Director General of the ACT Economic Development Directorate, Kareena Arthy and her executive team on many issues relating to the management of the Covid-19 pandemic. Topics covered included everything from the impact on our respective sectors of restrictions imposed by the Chief Health Officer to the ACT Government's Business Support Packages, QR Codes and the CBR Voucher initiative
- Members of the Forum briefed the ACT Greens Party Room on the state of the industry as part of a series of briefings to all ACT MLA's
- A roundtable with 30 industry representatives was arranged with the new Minister for Business and Regulatory Reform Tara Cheyne. As a result a 16 page report was prepared by the Leaders Forum for Minister Cheyne as part of the industry consultation the Directorate was undertaking on her behalf.
- ACT budget deliberations and discussions were held with a cross section of ACT Directorates prior to the 2021 ACT Budget being delivered
- Discussions were held with Events ACT on how the industry could support their team during Covid restrictions and also on their appointment of a consultancy to develop an events strategy for the ACT
- Support for the cancelled National Folk Festival, the future of Floriade and Enlighten and other scheduled events during Covid were discussed
- Noel Langdon represented the Tourism Leaders Forum on the ACT Planning Directorate's review of the Territory Plan
- The Government's communication to the industry was enhanced as a result of feedback from Tourism Leaders Forum members
- There were several discussion surrounding the impact of Covid on the visitor economy including meetings with Destination Southern NSW focussing on the free flow of visitors across our respective borders. Topics also explored with several agencies and industry operators were workforce shortages, international university students return to the ACT, vaccine rollouts, the impact on the aviation industry, the dilemma faced by the business events sector and school excursions ceasing to the national capital. A priority was also having public servants returning to the workplace.



Other discussions with industry sectors

- The significant impact on the tourism industry overall particularly attractions, accommodation and the hospitality sectors were foremost in the minds of the Tourism Leaders Forum. These sectors along with the arts community and sporting associations were dramatically impacted by Covid-19
- Conversations on the ACT night time economy began with the aim of opening the city to far more activation from 6.00pm of an evening
- Funding for sports generally was the subject of considerable discussion again this year, particularly the Kanga Cup that drew thousands of competitors and visitors to the ACT in the past, but was cancelled this year, a casualty of Covid-19 restrictions.
- The enticing of the Big Bash League and other national sports fixtures to Canberra was a priority for the ACT
- General Manager of the Arboretum and Stromlo Forest Park Scott Saddler conducted a tour for the Board of Stromlo Forest Park
- Meetings were held with Malcolm Snow CEO of the City Renewal Authority on their Precinct Renewal Programs
- Discussions were held with Brand Canberra Board members and others on the CBR Brand and its evolution
- International Engagement Commissioner Brendan Smyth liaised with the Leaders Forum on his dealings with tourism-related businesses struggling to cope with the downturn in visitor numbers, in his capacity as Commercial Tenancy Mediator (Business Commissioner) to assist commercial landlords and tenants to negotiate mutually agreeable outcomes

Federal Government and National Issues

- Meetings were held regularly with the Chief Executive of the National Capital Authority Sally Barnes. Many matters were discussed surrounding the Parliamentary Precinct and its importance to the tourism sector, including the new event guidelines the NCA had developed
- Attended meetings in support of the National Museum of Australia's initiative in establishing the 'Culture Loop' bus shuttle service supported by many of the National Attractions which sadly closed late last year after a 12 month trial
- Discussions were held with the Department of Communications relating to the Morton Report and the National Capital Education Tourism Project, and with the Federal Department of Communications re school visits to the ACT
- Discussions were held with Tourism Industry Council Executive Director Simon Westaway, Australian Chamber Tourism Chair John Hart, and Tourism and Transport Forum's CEO Margie Osmond.
- Johnathan Kobus, Michael Thomson and David Marshall participated in online 'Team Meetings' initiated by Australian Chamber Tourism on the proposed 'travel bubble' between Wellington and Canberra
- Meetings were held with several National Institution Directors



ACT industry sector liaison and issues addressed

- Discussions were initiated on the problems facing visitors to our National Institutions, allowing only limited numbers of visitors at a time due to density limits, and the logistics of ticketed timed entry
- Meetings were held to explore the financial challenges restaurants and coffee shops faced due to the 4sqm rule and seating limitations and also with hotels who were dramatically impacted by travel restrictions and thus low occupancy levels
- Testing of new social distancing technology was trialled at the Canberra Region Tourism Advisory Forums by the Canberra Convention Bureau
- Meetings were held with the Canberra Business Chamber on tourism and related business issues as part of the Tourism Leaders Forum's Kindred Organisation membership of the Chamber
- Steve Wood and then David Marshall represented the Tourism Leaders Forum, on behalf of the Canberra Business Chamber, on the Australian Chamber's National Tourism Board
- Through an initiative of the AHA ACT, the Tourism Leaders Forum joined forces to conduct pre-election forums in each ACT electorate in September and October 2020, inviting local candidates to present their ideas and to directly hear the plight of ACT tourism and hospitality operators.
- Gary Watson briefed the Tourism Leaders Forum Board on the school excursion market and impact of the discontinuation of interstate school visits to the ACT

The Canberra Region Focus

Members of the CRTLF attended many industry functions, launches and openings during the year, but in particular:

Media Activity

Since 1 July 2020, media coverage included 117 interviews on a variety of tourism related issues on Radio 2CC, ABC Radio, MixFM and 104.7, and articles in the Canberra Times and the Riot ACT, and on ABC and WIN Television

The Canberra Region Tourism Leader Forum is developing a website to promote our activities, and it will also enable our 500 plus invited members being able to register online for the Canberra Region Tourism Advisory Forums. This will be completed in early 2022
